Notice is hereby given that an Extraordinary General Meeting of the shareholders of RAK Ceramics (Bangladesh) Limited will be held on Sunday, September 20, 2015 at 10:30 a.m. at International Convention City, Bashundhara (Pushpoguscho), Joarshahara, Purbachal Link Road, Khilkhet, Dhaka-1229, Bangladesh to transact the following businesses and, if deem fit, to adopt the following resolutions as proposed by the Board of Directors:

"RESOLVED that the equity investment in RAK Power Pvt. 2. To consider increasing the equity investment in RAK Security and Services (Pvt.) Ltd. from the existing 35% to 100% through purchase of shares from the other shareholders of Security and Services (Pvt.) Ltd.

Proposed Extraordinary Resolution:

"RESOLVED that the equity investment in RAK Security and Services Pvt. Ltd. may be increased from the existing 35% to 100% through purchase of 6,500 number of ordinary shares of BDT 100/- each from all the other shareholders of RAK Security and Services Pvt. Ltd.
